###### DRIVING DIRECTIONS:

From the East and West:

Take the 610 Loop to Interstate 45 North.

Take exit 600 for the Sam Houston Expressway.

Take a right onto Sam Houston Expressway.

Travel about 1 mile east to Imperial Valley Drive.

Drive under the Beltway.

Take a right on the street immediately north of the Crowne Plaza Hotel.

From the North and South:

Take Interstate 45.

Exit on Sam Houston Freeway.

Take a left onto the Sam Houston Expressway about 1.5 miles east to Imperial Valley Drive, under Beltway 8, which is about a block on the right immediately behind the Crowne Plaza hotel.
