#### Transportation

##### DRIVING DIRECTIONS:

Driving south on the 5 freeway, e r Harbor Boulevard or Exit 3 (Exit 109 B is just past Harbor Boulevard and is named Disney Way.)

From the Harbor Exit, turn right onto Harbor Boulevard.

Turn left onto Manchester Avenue at the first light.

Continue on Manchester Avenue to 1585 South Manchester.

The office is on the right.

From Exit 109B, turn right onto Disney Way.

At the first light, turn right onto Clementine Street.

At the stop sign, turn left onto Alro Way and head toward the Immigration Building.

Driving North on the 5:

Exit the 5 Freeway on Katella Avenue, (Exit 109) toward Disney Way.

Take a slight left onto Anaheim Way.

Take a slight left onto Disney Way.

Stay on Disney Way to Clementine Street.

Turn right onto Clementine Street.

At the stop sign, turn left onto Alro Way and head toward the Immigration Building.

By surface streets, take Harbor Boulevard to Manchester Avenue.

Turn east onto Manchester Avenue.

Continue on Manchester Avenue to 1585 South Manchester.

The office is on the right side.

The closest landmark is Disneyland which is on the west side of Harbor Boulevard between Ball Road and Katella Avenue. Manchester Avenue is east of Disneyland between Ball Road and Katella Avenue.

**PUBLIC TRANSPORTATION:**

Public transportation is available through the Orange County Transit Authority ([www.OCTA.net](http://www.OCTA.net)).

The closest train station is the Metrolink station at 2150 East Katella Avenue, Anaheim CA 92806.
