Effective October 15, 2018, the Executive Office for Immigration Review, Office of the Chief Immigration Judge will open a new detained only immigration court to serve the Houston, TX area of operations. The court will be known as the Conroe Immigration Court. The court will be located at the following address:

The main phone # at the Conroe Immigration Court is 936-520-5400. Customer service window hours at the Conroe Immigration Court will be 8:00am to 4:00pm Monday through Friday. The window will close for lunch from 12:00pm to 1:00pm.

Also, effective October 15, 2018 the customer service window at Houston Detained Immigration Court 5520 Greens Road will close. Court filings at 5520 Greens Road will only be taken in court on cases pending before the judges presiding at the Greens Road hearing location. All court filings for all hearing locations under the Conroe Immigration Court should be mailed to the Conroe Immigration Court address or hand delivered to the customer service window at the Conroe Immigration Court.

The Houston Service Processing Center falls under the jurisdiction of the <u>Office of the Chief Immigration Judge</u>, which is a component of the <u>Executive Office for Immigration Review</u> under the <u>Department of Justice</u>.

The <u>U.S. Citizenship and Immigration Services (USCIS)</u> and <u>Immigration and Customs Enforcement (ICE)</u> are part of the <u>Department of Homeland Security (DHS</u>) and are therefore separate from the Executive Office for Immigration Review (EOIR).
