## **USCIS Closes the Ciudad Juárez Field Office**

USCIS has permanently closed its field office in Ciudad Juárez, Mexico, as of June 30, 2019. The <u>U.S. Consulate</u> General in Ciudad Juárez will assume responsibility for certain limited services previously provided by USCIS to individuals residing in the Mexican states of Baja California Norte, Baja California Sur, Chihuahua, Durango, Sinaloa, and Sonora (see table below).

Beginning on May 31, 2019, individuals who were previously assisted by the USCIS Ciudad Juárez Field Office must follow these filing instructions:



Service/Form	Filing Instructions
<u>Form I-130, Petition for</u> <u>Alien Relative</u>	File your petition by mail with the USCIS <u>lockbox facility in Chicago</u> . You can find additional filing information on the <u>Form I-130 web page</u> .
	USCIS may authorize the Department of State to accept a petition filed with a U.S. embassy in <u>some limited circumstances</u> (PDF, 61 KB).
<u>Form I-360, Petition for</u> <u>Amerasian, Widow(er),</u> <u>or Special Immigrant</u> (for Widow(er) petitions only)	If you are a widow(er) of a U.S. citizen, please see the <u>Form I-360, Petition for</u> <u>Amerasian, Widow(er), or Special</u> <u>Immigrant</u> page for the most current filing instructions.
	You may file your <u>Form I-360</u> at the U.S. embassy or consulate that has jurisdiction over the area where you live.

Service/Form	Filing Instructions
<u>Form I-407, Record of</u> <u>Abandonment of Lawful</u> <u>Permanent Resident</u> <u>Status</u>	Follow these instructions for <u>Form I-407</u> . In rare circumstances, a U.S. embassy or U.S. consulate may allow you to submit a Form I-407 in person if you need immediate proof that you have abandoned your lawful permanent resident status.
<u>Form I-601, Application</u> <u>for Waiver of Grounds of</u> <u>Inadmissibility</u>	File your Form I-601 by mail with USCIS. The filing location depends on the immigration benefit you are seeking. To view a complete list of addresses, go to our <u>Direct Filing Addresses</u> page.
