Clerical Transfers Allowed

Note: In certain instances two Immigration Courts will share administrative control for a location. Typically, this sharing occurs when the two courts are located in the same geographic area - one in a detention center or prison and the other in a non-detained setting. In such instances, a case can be transferred between the paired courts with only an administrative notation. A request to change hearing location to any other site must comply with the change of venue regulation at 8 C.F.R. § 1003.20. In addition, all filings and other administrative requests must be made to the primary administrative control court and not to its paired counterpart.
